# NAP Sample – Civics and Citizenship online assessment NAP-CC 2024 Field trial (Oct/Nov 2023) Privacy Notice

This notice is to advise you that your child has been selected to participate in the National Assessment Program Civics and Citizenship Literacy (NAP-CC) field trial conducted online by the Australian Curriculum, Assessment and Reporting Authority (ACARA).

Only limited, personal information about your child will be collected as part of the trial.

ACARA handles all personal information in accordance with the *Privacy Act 1988* (Cth).

### What is the NAP-CC field trial?

ACARA develops the NAP–CC test, which is trialed in a selection of schools in Queensland, Victoria, New South Wales, South Australia and Western Australia.

The purpose of the trial is to evaluate potential questions for use in the NAP-CC 2024 main study event. The trial is about testing the questions, not about testing your child, or their ability. Your child's results are not reported.

# **Collection**

Section 40(1) of the *Australian Curriculum, Assessment and Reporting Authority Act 2008* (Cth) authorises ACARA to collect personal information for specific purposes including producing national reports and assisting government to formulate education policies.

For the purposes of this notice, ACARA includes itself and any authorised contractors. ACARA will collect limited personal information about your child and their school when your child completes the online trial. ACARA does **not** collect student names as part of the trial.

ACARA will collect the following categories of information for each student (Year 6 or Year 10) and school that participates in the trial:

- <u>Data collected from each school</u>: class name, for example, 6H, number of students enrolled in each class, school street address and school suburb;
- Other de-identified data collected by ACARA through our contractors (excluding data collected from students): de-identified student username, school name, contractor school identifier and year level; and
- <u>Data collected from each student</u>: gender (collected to test for question bias) and participation and performance information derived from student responses to multiple choice and free text questions.

The student will not be able to participate in the trial unless this information is collected.

If you do not want your child to participate, please liaise with the selected school.
